# What is the Transportation Alternatives (TA) Program?

#### Bipartisan Infrastructure Law (BIL)

Under the Bipartisan
Infrastructure Law (BIL)'s Surface
Transportation Block Grant
Program:


- The Transportation Alternatives Set-Aside provides funding for projects that help States build a variety of generally smaller-scale alternative transportation projects
- These projects are meant to achieve safer, connected, and equitable on-and off-road networks for all users

Due to the way that the federal government suballocates funding, ADOT's TA Program focus only on Greater Arizona

 Greater Arizona includes parts of the State outside of the Maricopa (MAG) or Pima (PAG) Association of Governments regions.

For Tribal Governments with boundaries that fall both within and outside of the MAG and PAG regions:

- Any eligible project located within MAG or PAG is eligible for TA Program funding through MAG or PAG's TA Program.
- Whereas any eligible project located outside of the MAG or PAG regions is eligible through ADOT's TA Program.
- This currently only applies to Tohono O'odham




Greater Arizona includes all areas outside of the MAG and PAG regions (in gray)

FHWA's TA Program Guidance serves as the technical foundation for ADOT's TA Program.



#### **Ineligible Costs**

- Right-of-way (ROW) acquisition costs are not eligible
  - Once ROW acquisition or ROW agreements are competed, the project can seek TA Program funding
  - This restriction does not include temporary construction easements
- Other ineligible activities can be found on page 23 of FHWA's TA Program Guidance.





## **Project Development Support**



The TA Program can provide project planning/scoping funding to help ensure communities are able to start new projects and later compete for design and construction funding.



ADOT Project Development Administration (PDA) fees are an eligible expense to further reduce barriers to the TA Program.



## **Available Funding**

Greater Arizona has ~\$16 Million in TA Set-Aside funds available for the current program cycle


There are currently **no minimum or maximum** project award amounts designated. This may change for future TA Program cycles.

The **required local match** for TA projects will be in accordance with the federal sliding scale rule for Arizona.

- Most local government projects in Arizona are eligible a 5.7% minimum local match, with some exceptions.
- Tribal Governments can use funds under 23 U.S.C. 202 or 23 U.S.C. 203 to pay the non-Federal share of the cost of any project that is funded under title 23, or under chapter 53 of title 49, U.S.C., that provides access to or within Federal or tribal land.

Planning/Scoping and Programming projects are administered by Regional Planners/Tribal Planning Coordinators within ADOT's Multimodal Planning Division.

Design and Construction projects are administered through ADOT's Local Public Agency Section.

ADOT will review Tribal Government requests to transfer funding through the ADOT 202(a)(9) Intergovernmental Funds Transfer Agreements (IFTA) process on a case-by-case basis.



These activities can take place concurrently and can be interdependent

## **Application Process**





#### **Two-Step Application Process**



#### **Step 1: Screening Application**

The screening application is designed to ensure project readiness from ADOT's perspective



#### **Step 2: Evaluation Application**

The evaluation application will be evaluated, scored, and prioritized by the TA Technical Advisory Committee.

The Project Sponsor will submit the application unless they are required to partner with a public agency or local government, in which case the public agency or local government would submit the application.

Applications will be submitted via an <u>online application</u> on ADOT's <u>TA Program</u> <u>webpage</u>.





## **Screening Criteria**

## "Yes" for all criteria is required for a proposed project to move forward to a detailed application


Criteria	Score
Is the applicant eligible to sponsor a TAP project?	Yes/No
Is the project activity eligible for TAP funding?	Yes/No
Is the proposed project schedule realistic and feasible to complete without major challenges or delays?	Yes/No
Is the project located outside of MAG and PAG planning boundaries?	Yes/No
Has the sponsor documented a source for local match funding with a commitment letter?	Yes/No
Is the proposed Year of Expenditure cost estimate sufficient to cover the proposed scope of work?	Yes/No
Has the local COG or MPO indicated support for the project? (not applicable to Tribal Governments)	Yes/No





#### **Screening Application**

- The screening application is a webbased form that allows project sponsors to answer questions and submit spatial project information.
- Screening applications will be accepted between July 17<sup>th</sup> August 18<sup>th</sup>

## **Screening Application Required Attachments**

A summary of the attachments Project Sponsors are required to upload into the screening application include the following:

- Letters of Support from MPO or COG corresponding Special cases:
  - MPO or COG letter of support from the facility owner is required
  - Tribal Government letter of support from the facility owner is required
- 2) Letter of Commitment for Local Match
- 3) Project Cost Estimate





## **Screening Application Review**

- Members from ADOT's Local Public Agency section and Multimodal Planning Division will review screening applications
  - This gives ADOT project delivery staff an opportunity to review projects, giving them a chance to catch potential issues that are more easily addressed early on. This is especially true for design and construction projects.
    - For example, it's better to ensure an accurate construction cost estimate to avoid a project coming in well over budget. That overrun would be the responsibility of a Project Sponsor to cover. It's in everyone's interest to avoid that situation.
  - ADOT's review will help ensure smoother sailing after projects are awarded and help ADOT meet federal funding deadline requirements.

#### **Technical Quality of Scope Criteria**

#### Scope

The questions will be tailored to the project type. The full list of scope questions by project type is available for review in the TA Program Guidebook.

#### Design

PS&E complete questions and design plans required if project involves construction.



#### **Schedule Criteria**

Provide the expected program year for the project. Provide program years for scoping, design, and construction if relevant.







#### **Community Support Criteria**

- Before submitting the application, project sponsors should acquire community input and support from local/tribal/state agencies, elected officials, COGs and MPOs.
- Support letters from local government officials, tribal officials, community groups, regional organizations, and/or state agencies are encouraged and will be accepted as part of the application package.
- Evidence of public involvement, such as informational brochures, public meeting minutes, or newspaper articles are not required, but support the application.
- Please upload support letters with the detailed application. Do not have them sent directly to ADOT.





#### **Plan Alignment Criteria**

List any transportation-related plans the proposed project aligns with and supports and describe how the project is align with them.

List any state and/or community transportation-related plans that the proposed project aligns with and supports.
Project Alignment
Describe how the proposed project aligns with each plan identified above. Include a description of your project's alignment to each plan's goal, objectives, and/or identified solutions as relevant.





#### **Equity Criteria**

Projects will be scored based on the income level within the project's access shed.
 Access shed distances vary based on project types:

Pedestrian Facilities: 0.5 miles

• Bicycle Facilities: 1.5 miles

Transit Facilities: 1.5 miles

• The <u>Climate and Economic Justice Screening Tool</u> will score the census tracts that the project lies within based on eight disadvantage indicators:

- Climate Change
- Energy
- Health
- Housing


- Legacy Pollution
- Transportation
- Water and Wastewater
- Workforce Development





## **Evaluation Application**

- The evaluations application is a webbased form.
- If the project passes the screening review, the designated point of contact will receive a custom link to complete the evaluation form.







#### **Evaluation Application Required Attachments**

A summary of the attachments Project Sponsors are required to upload into the evaluation application include the following:

- Right-of-Way Acquisition Documentation (if the project involves construction)
- Design Plans (if the project involves construction)
- Letters of Community Support
- Evidence of Public Outreach

## **Technical Advisory Committee**

- The TAC has 16 members:
  - 12 voting members representing Greater Arizona's MPOs and COGs, the Inter-Tribal Council of Arizona, and the Arizona Department of State Park & Trails.
  - 4 advisory members including, a statewide non-profit representative, Maricopa Association of Governments (MAG), Pima Association of Government (PAG), and Federal Highway Administration (FHWA).
- The ADOT TA Program Manager is the primary liaison between ADOT and the TAC and serves as a technical and administrative resource to the Committee.



#### **Project Evaluation**

The TAC reviews Evaluation Applications and provides judgement-based input covering the following evaluation criteria:

- Letters of support
- **Public Involvement**

#### **Plan Alignment**

✓ How well does the project support related planning efforts?

#### **Federal Requirement**

The competitive process must prioritize project location and impact in high need areas 23 U.S.C. 133(h)(4)(D)





The equity criteria score, based on the project's travel shed inclusion of a transportation disadvantaged community and median household income, is automatically calculated based on the project's location.



#### **Evaluation Results & Surface Transportation Board**



The evaluation process will result in a prioritized project list which is then further informed by the amount of available TA program funding.





The recommended prioritized project list based on available funding is sent to the Arizona State Transportation Board for further consideration and project award approval.



Awarded projects are announced via email to Project Sponsors and respective MPO/COGs are notified.



#### **Project Agreements**

- The Project Sponsor executes IGAs/JPAs with ADOT. Agreements should be being as quickly as possible because they take about 3 months to complete.
  - IGAs are agreements between ADOT and other governments
  - JPAs are agreements between ADOT and other non-government entities
- ADOT's JPA Section has more information such as how to initiate a project agreement on their webpage & FAQs





## **TIP Programming**

- The Project Sponsor will need to execute a TIP amendment or administrative modification.
- The Project must be programmed into a fiscally constrained program year on the regional TIP to be included in the STIP.
- ADOT will coordinate with Tribal Governments to determine the best way to program projects.





#### **Project Initiation**

# Planning/Scoping & Programming Projects

Project Sponsors will work with the appropriate ADOT Regional Planners and Tribal Planning Coordinators <u>assigned to their region</u> to initiate their planning/scoping or programming projects.

Planning/scoping and programming projects will be administered through <u>ADOT's</u> <u>Multimodal Planning Division</u> (MPD).

#### **Design & Construction Projects**

Project Sponsors will prepare and submit a Project Initiation request form to the ADOT LPA Section to receive ADOT Project and Federal ID numbers.

Project Initiation request forms and supporting documentation forms can be found on the <u>ADOT LPA Resource</u> <u>Materials Webpage</u>.


ADOT will review Tribal Government requests to transfer funding through the ADOT 202(a)(9) Intergovernmental Funds Transfer Agreements (IFTA) process on a case-by-case basis.



## **Project Delivery Timeline**

- While the timeline on any given TA
   Program project may vary it may not exceed 4 years when including all phases.
- The project phase schedule that was submitted during screening application may be refined once an ADOT project manager, regional planner, of tribal planning coordinators has been assigned to the project.
